Differences between Brazil's and USA's Supreme Courts



Brazil and the United States are two of the largest democracies in the world and they share some similarities in their political systems. However, when it comes to their Supreme Courts, there are significant differences in their structures and roles.

Firstly, the Supreme Court of Brazil is composed of 11 justices, while the Supreme Court of the United States is composed of nine justices. Additionally, the Brazilian justices are appointed by the President of the Republic, with the approval of the Senate, and they serve until they reach the age of 75 years old. On the other hand, the American justices are appointed by the President of the United States, with the approval of the Senate, and they serve for life or until they resign, retire, or are impeached.

Secondly, the role of the Brazilian Supreme Court is broader than that of the American Supreme Court. In Brazil, the Supreme Court has the power of judicial review over any law or act of government, including those enacted by the President or the Congress. This means that the Brazilian Supreme Court can declare laws or acts unconstitutional, null and void. In contrast, the American Supreme Court can only review the constitutionality of laws and acts that are brought before it in specific cases, through a process called judicial review.

Thirdly, the Brazilian Supreme Court has more justices than the American Supreme Court because of its role as a constitutional court, which means that it has to deal with a wider range of legal issues, including those related to the constitutionality of laws and acts of government. The American Supreme Court, on the other hand, has a more limited role, as it mainly deals with cases that are brought before it through the process of judicial review.
